**Booking Hours: -**

- a. Normal booking hours are 8:00 am to 11:30 pm, extendable at the discretion of the management.
- b. The sale of alcohol, subject to licence, to end by 11:30 pm in all cases.
- c. The Hirer is responsible for preventing any nuisance from noise. It is a requirement that music shall suitably muted, and doors and windows closed after 11:00 pm to avoid disturbing neighbours. playing
- d. The Hirer is responsible for removing all rubbish from the field and pavilion.

**Deposits & Security Bonds: -**

- a. Short period (up to one day), one off or occasional bookings: - full hire fee payment will be required at the time of booking. Regular booking fees must be paid in advance.
- b. Bookings for larger events with long forward notice to be secured with a 25% deposit, and the balance must be received at least 8 weeks before the event.
- c. Should the hirer later cancel the booking the fee will be forfeit unless the Trustees are able to secure an alternative equivalent hiring.
- d. A Security bond of £30 will be required on all events and must be paid at least 14 days before the event. If payment is not received the booking will be deemed to be cancelled. Charges against this deposit will be made for any additional cleaning, repairs or loss replacement if found necessary. This includes the refilling / replacement of firefighting equipment if used in a non-fire situation, and the non-return of keys (£35 or actual replacement cost).
